Those who cannot use the “TOWER SLIDER”

- Those under 6 years old.
- Those who are under the influence of alcohol.
- Those who are anxious about light stimulation.
- Those over 66 years old
- Those who are anxious about their vision or limbs.
- Those who are anxious about heights, confined spaces, or dark places.
- Those who are less than 4 ft in height
- Those who are mentally or physically unstable.
- Those who are unable to maintain a stable sliding posture due to the inability to wear a gliding bag.
- Those who weigh 221lbs or more.
- Those who are prone to motion sickness.
- Those who are unable to understand and strictly adhere to the precautions given by the staff.
- Pregnant.
- Those with bone conditions.
